# AUTHORIZING AMENDMENT TO PROFESSIONAL SERVICE CONTRACT FAIR AND OPEN LEGAL SERVICES LeCLAIR RYAN (\$20,000.00)

WHEREAS, the County awarded a professional services contract to investigate and evaluate allegations of sexual and workplace harassment and hostile work environment and discrimination against the County or County employees for the period of January 1, 2008 through December 31, 2008 to the law firm Seiden Wayne, LLC, now called LeClair Ryan, on December 27, 2007 by Resolution No. 594-12-2007; and

WHEREAS, such services were acquired through a fair and open process pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the maximum amount of the contract award was not to exceed ONE HUNDRED THOUSAND1 (\$100,000.00) DOLLARS with an attorney rate of ONE HUNDRED FIFTY (\$150.00) DOLLARS per hour; and

WHEREAS, due to increases in workload it has become necessary to add to the contract amount in order for the firm to provide the services required by the County; and

WHEREAS, it has been determined that the firm's expertise will also be needed to provide legal guidance to an outside correctional facility consultant who would review disciplines imposed at the Hudson County Department of Corrections to determine whether the disciplines and the penalties imposed were appropriate; and

WHEREAS, the County now wishes to amend the aforesaid contract to add an additional TWENTY THOUSAND (\$20,000.00) DOLLARS for a total contract amount of ONE HUNDRED TWENTY THOUSAND (\$120,000.00) DOLLARS; and

WHEREAS, funds for this purpose are available in Account No. 0003B as certified by the Director of the Department of Finance and Administration; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., permits the awarding of a contract for professional services without public advertising for bids, and requires that the resolution and the terms be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders to the County of Hudson, that:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length.
- The Board hereby authorizes the County Executive, or his lawfully appointed designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this resolution.
